It's even more exciting with the growth of the Central Florida Warriors (CFW) Hockey! In 2023, CFW Hockey won two national-level tournaments and attended the NHL Stadium Series Veterans Showcase in Raleigh, NC. (one of four veteran hockey programs selected nation wide). In 2024, we are now able to separate the program in to three teams based on skill level, allowing individuals to more fully enjoy the therapeutic effects of sport of ice hockey.

CFW Hockey is a public charity comprised of more than fifty U.S. military members and veterans who were injured during their time in service to this country. Florida has the third largest veteran population in the nation, behind California and Texas. Program members come from a diverse background and have served in every branch of the armed forces. Their service spans both peace time and war time, including many deployments around the world.
